Student completes Expression of Interest electronic form

Students interested in applying for a VET course **that requires an interview (listed below)** must complete electronic EOI form, with support from Grade 10 advisors.

If students wish to apply for multiple courses, a separate EOI must be completed for each course.

Student to select an interview time for the selection process interviews via the appropriate hyperlink in email

Select interview time from email received after EOI completed – confirmation email will be sent, which will include additional interview instructions and information.

If none of the times given are suitable, student/parent to contact Andrea explaining extenuating circumstances – andrea.brooke@decyp.tas.gov.au. The relevant course coordinator will then contact student to establish an alternative time.

The selection process

The selection process is a chance to determine the suitability and readiness of a student to undertake a VET qualification. We encourage all interested students to apply and go through the selection process. Candidates must ensure they bring relevant documentation as specified in the VET additional instructions and information that was sent with interview confirmation.

Candidates to present at LC reception in A block and will be directed to interview space from there.

Post-selection/interview process

All candidates will receive a letter with outcome of the selection process.

Feedback for suggested improvement for a candidate can be made available at candidate request. Appeals process will go through the VET AP.

Applicants need to understand that this is a comparative process based on the field of candidates who apply and the number of spaces available.

If a VET course cannot run due to insufficient numbers, candidates may be contacted directly to offer alternatives, or student may be re-counselled into TASC courses as necessary.
